How to Claim Credit

- **How will I be able to claim credit?**
 1. Visit: <https://ucsd.cloud-cme.com/default.aspx>.
 2. Log in to your CloudCME account using your SSO credentials. Don't have an account, use these [instructions](#) to create an account.
 3. Click "**My CME**" in the top-right corner, then select "**Claim Credit**".
 4. Enter **Activity ID: 15018**, complete the evaluation and download your certificate.

 1. Log in to your CloudCME profile.
 2. Click on **MyCME** in the top-right corner of the page.
 3. Navigate to the **Evaluations and Certificates** section.
 4. Locate the course titled **UC San Diego Health: Annual Required Training**.
 5. In the "Evaluations" column, click the gray **Complete Evaluation** button to resume and complete your evaluation.

Types and Numbers of Credits Offered

- **What types of credit are available for completing the courses?**
