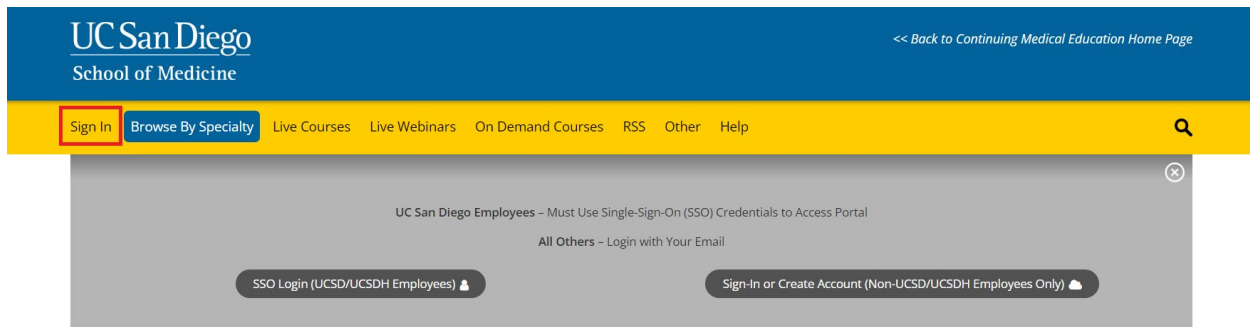
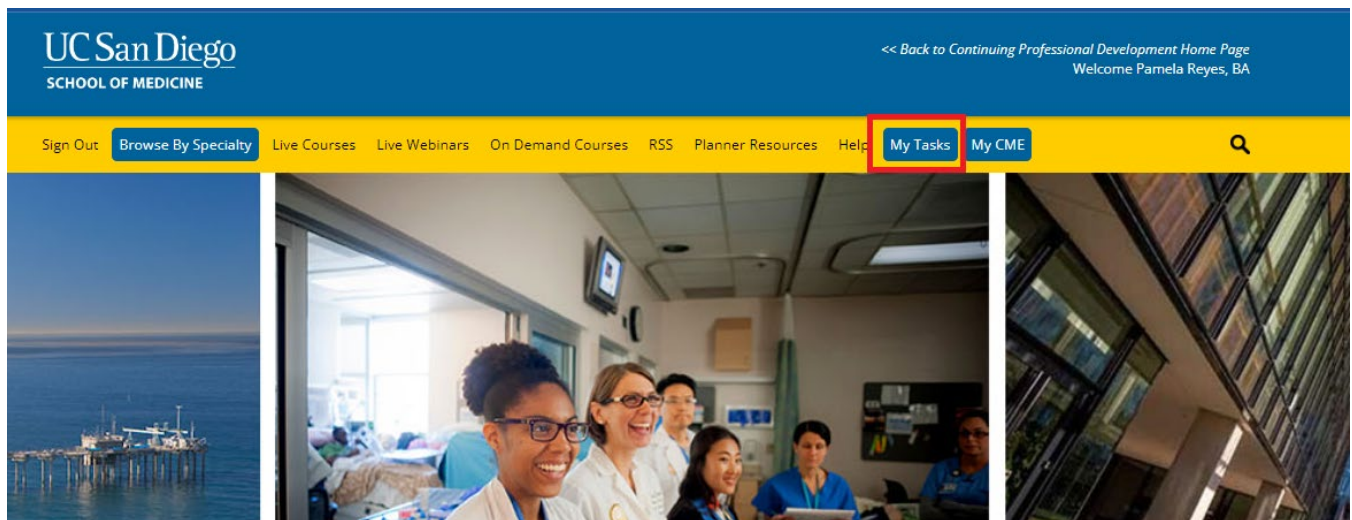


- **Step 1: Sign In** to CME Portal, <https://ucsd.cloud-cme.com/default.aspx>.
